Applications for stabling and bedding must be made on this form. Stables will be allocated to the extent to which they are available prior to the show and changes will only be made at the discretion of the Championships Committee. This form does not guarantee stables but The Society will endeavour to fulfill all requests. Stables will be allocated on the basis of entries arriving at AHSA Office, distance travelled, Sponsors of the Championships and number of horses entered. Please note that Stables are **NOT** to be used as Tack Rooms.

**FEES:**

- Stables:** \$19.50 per horse, per day/night (between 6am and 6am)  
\*\*PLEASE NOTE TIME CHANGES FROM PREVIOUS YEARS\*\*
- Bedding & Feed:** Shavings will be approximately \$13.50 per 20kg. A small amount of Initial bedding **IS** supplied prior to occupancy of the stable. Additional bags & all your feed needs may be ordered directly through AELEC. Additional bedding may be purchased from the AELEC Office throughout the show.
- Stable Bond:** \$50.00 Bond PER STABLE is payable by separate payment upon entry. (See Below) Stables may not be booked through AELEC. Stables need to be cleaned out on departure. & Bonds will be returned when AELEC Officials have inspected the stables for cleaning & damage & given authorisation. (See bottom section) AELEC decision is final.
- Day Parking Fee:** \$5.00 per horse, per day.
- Camp Sites:** \$18.00 per night. Campsites are allocated to you. Anyone not in their allocated site will be removed. Again, these sites will be allocated on a "first in" basis.

### Horse Sports are a Dangerous Activity

In consideration for being permitted to participate in any way in horse sport activities and in particular this event, I, the undersigned, understand, acknowledge and accept that:

Horse sports are a dangerous recreational activity and horses can act in a sudden and unpredictable (changeable) way, especially if frightened or hurt.

There is a significant risk that serious **INJURY** or **DEATH** may result from horse sport activities and in particular this event.

I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the proprietors of the Arabian Horse Society of Australia Ltd and/or the event organiser (hereafter referred to as the "Releasees") or others and **I voluntarily PARTICIPATE** at my **OWN RISK** and assume sole responsibility for any injury, death or property damage I may suffer that arises from my participation in horse sport activities.

I understand and acknowledge the dangers associated with the consumption of alcohol or any mind altering drugs before and during the activity and I take full responsibility for any injury, loss or damage associated with their consumption. I agree not to drink alcohol or take drugs prohibited by law before or during this event.

I agree to follow the directions of any event organiser or official and that any misconduct or refusal by me to follow any direction of any organiser or official can result in the **CANCELLATION** of my participation in the event and my immediate removal from my horse **NO MATTER** where that may occur. I further agree to abide by the Rules and Conditions of this show, all Rules of the Showground regarding the use of their centre and it's facilities and the current Rule Book of the Arabian Horse Society of Australia. I understand that any such non-compliance may result in injury, death and/or permanent disability and I agree to indemnify the Releasees against all claims made by any person as a result of my failure to comply.

I agree to wear a helmet at all times whilst riding and agree that I am solely responsible for ensuring that I wear a suitable helmet at all times and take sole responsibility for my actions.

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release and hold harmless and agree not to sue the proprietors of the Arabian Horse Society of Australia Ltd and/or the event organiser, their officers, officials, volunteers, coaches, agents and/or employees, other participants, sponsoring agencies, sponsors, state bodies, affiliated clubs and if applicable, owners and lessors of premises used to conduct the activities (all of whom are referred to as "Releasees") with respect to any and all injury, disability, death, or loss or damage to person or property, whether caused by the negligence of the releasees or otherwise.

I understand that due to diseases such as equine influenza, the Department of Primary Industries, or other state or commonwealth government bodies may restrict or prevent the movement of horses, vehicles and personnel for a time period, otherwise known as a "standstill". I acknowledge that a standstill is a risk of competing and agree to pay any costs or expenses incurred by any person or organisation for and on behalf of my horse(s) as a result of the standstill.

### Effect of this Document

I have had sufficient opportunity to read this release of liability and assumption of risk agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without inducement of any kind. I understand that my signature to this document constitutes a complete and unconditional release of all liability of the Releasees, to the greatest extent allowed by law in the event of me and/or the children under my care, suffering injury or death.
